**INFORMATION ON THE PROCESSING OF PERSONAL DATA
 (UE REGULATION 679/2016 ART. 13)**

According to the art. 13 of EU Regulation 679/2016 (GDPR) concerning the processing of personal data (hereinafter the Regulation) and in relation to the personal data you communicate and which will be the object of the processing 1, we wish to inform you that the personal data you may provide will be the object of processing in compliance with current legislation and the confidentiality obligations to which the writer is bound.

2. Place of processing

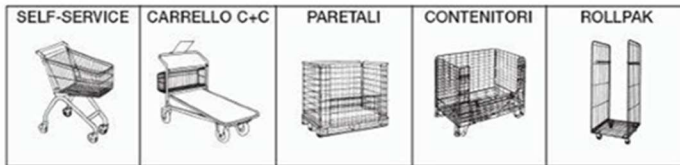
The processing operations connected to the web services of this site take place at the headquarters of the Owner and are only handled by personnel specifically appointed for processing.

3. Types of data processed

3.1. Navigation data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of internet communication protocols. This information is not collected to be associated with identified interested parties, but the information could allow to identify the users through processing and association with data held by third parties, by its own nature.

This category of data includes the IP addresses or domain names of the computers used by the users connecting to the site, the URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server and other parameters relating to the operating system and the user's IT environment. 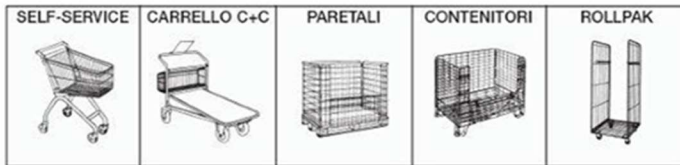
5. Processing methods

All appropriate technical and organizational measures will be applied to guarantee an adequate level of security to the risk, so as to ensure, on a permanent basis, the confidentiality, integrity, availability and resilience of the processing systems and services. of persons specifically appointed and in compliance with the provisions of art. 29 of the GDPR 679/2016.

6. Scope of communication and dissemination

The scope of communication of the data is limited exclusively to the subjects competent for the fulfillment of the contractual operations and the observance of legal obligations. They can therefore be communicated to third parties belonging to the following categories:

9. Data retention period

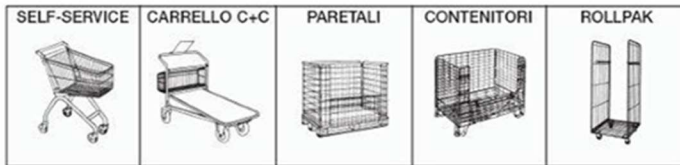
Personal data are stored according to the following criteria:

10. Rights of the interested party

The Regulation grants the exercise of specific rights, including those to ask the Data Controller:

- The confirmation that your personal data are being processed and, in the affirmative, the access to them (right of access), pursuant to art. 15 of the Regulation
- The rectification of inaccurate personal data, or the integration of incomplete personal data (right of rectification), pursuant to art. 16 of the Regulation
- The deletion of the data, if one of the reasons envisaged by the Regulation (oblivion right), pursuant to art. 17 of the Regulation exists
- The limitation of the processing when one of the hypotheses envisaged by the Regulation (right of limitation), pursuant to art. 18 of the Regulation exists
- To receive in a structured format, commonly used and readable by automatic device, the personal data supplied to the Owner and to transmit such data to another Data Controller (right to portability), pursuant to art. 20 of the Regulation
